If, not given appointment to represent my ST Community at the Apex Court, then I will exercise my fundamental right under Article-19(1)(g) & 14 to promote and protect the DEGNIFIED & HONEST society and to ensure the sustainable development of poor people I would immediately Start Private Practice as a Judge and will Create Parallel Private Transparent and Accountable Justice System in the country like private medical profession to give 24x7 hour's Access to Justice to the crores of Indian Citizen.

Rashtrapati Mahodaya ji,

I hope this email finds you in good health and high spirits. I am a Specialist Legal Scholar, have formal qualification in law and have outstanding understanding and knowledge of law, have acquired legal and juristic excellence in imparting quality justice. I had made genuine and sincere efforts to join the Delhi judiciary under my Schedule Tribe category but I was unlawfully prevented by the Delhi High Court by tampering my OMR sheet of 2022's Preliminary examinations. I had written about it to the then chief justice of Delhi High court Satish Chandra Sharma and to the CJI but they are suppressing this matter by keeping silence for two years now, I have lost the means of my livelihood and my dream of becoming CJI

one day due to their Silence and conspiracy, therefore I am writing this email to bring a matter of utmost importance to your attention, pertaining to the appointment of me to the Supreme Court of India under Article-124(3)(c) of the constitution, as I was prevented by the Delhi High Court from joining the Delhi judiciary in 2022, on the undue influence of my Rented Room's owner of N-2, first floor, Mukherjee Nagar, Delhi-110009 i.e. Pradeep Kr. Bajaj and his family, his hired two lady bouncers (i.e. convicted offenders of Tihar Jail called Puli@Poonam Saroha and Babli@Bhagwagti and Ravi Chopra and his wife, Anil Malik and one another male and on the influence of owners of House no.616, ground floor, Mukherjee Nagar, Delhi i.e. Smt.Pashmeen Kaur and her family, on the undue influence of Mukherjee Nagar police station, Pangi Police station, Ex.CM of HP-Jai Ram Thakur (i.e.for making complaints against their illegal and arbitrary actions in our ancestral property matters) the lady secretary & panel lawyer of Delhi High Court Legal Services Committee, by hatching conspiracies against me, they had tampered my OMR answer sheet of Delhi judicial service's preliminary examination-2022 with intentions to stop me from joining the Delhi judicial services. When I wrote about this to the then Chief Justice of the Delhi High Court Satish Chandra Sharma, he had suppressed the matter by keeping silence due to the fear or on getting bribe or on the influence of accused persons so that he could be elevated to the supreme court and now enjoying the fruit (Vide: my complaint of Dated:12.07.2022 i.e. Article no. RD856111636IN (Registered letter delivered by BEAT no.42) received by Ravinder of Article receipt room on 14.07.2022 at 13:23, pdf copy attached with this email) Then on 27.12.2022, I had written to the Chief Justice of India, Vide: pdf attached with this mail which was sent i.e. Article no.RD453943550IN (Registered letter) delivered by BIJENDER SIN Beat no: B20 on 28.12.2022 at 13:37:47. One year and 9 months has gone but it appears from his Silence that he will also not take any action to protect my legal, human and fundamental rights due to the fear or undue influence of accused persons and their political masters.

J.Satish Chandra Sharma and chief Justice of India are behaving as I am not a citizen of this country and I have no right to make genuine complaint against anyone or to get justice from the Delhi High court and from the supreme court. By keeping silence on my complaints they have promoted the Gunda Raj in the national capital. Corrupt people like Pradeep Bajaj, Pashmeen Kaur and their hired two female and 4 male bouncers, Delhi police, DWC, DHLSC were given free hand to destroy my life, livelihood, golden career in judiciary and to take away my belongings, phones, simcards, eating items, clothes, blankets, pillow books, footwears, to break the locks of my rented rooms in multiple times, to break the lights, wall and handles of my rented rooms. It was the legal duty of the Delhi police, WDC, Delhi HCLSA and Delhi High Court to protect the human, legal and fundamental rights of me on my complaint/application to them but instead of giving any protection or access to justice, they were committing conspiracies against me to fail me in my competitive exams and to force me to leave rented rooms and Delhi without any orders of any court. They may have thrown my complaints in dustbins on the instructions or influential of their political Gods and Chief Justice of a High Court like Delhi and Chief Justice of India cannot be prevented by other than Prime Minister or Home minister himself. If a Prime Minister or Home minister of a country or a Chief Minister of a State or chief justice of a high court or CJI is allowing it's State agencies/authorities to crush the Dreams of its Students, misappropriating their personal belongings, books and ancestral properties at home in arrogance of their political powers, he or she has no moral and constitution right to Govern the country and to sit as constitutional courts. They are behaving like a terrorist organisation and they must immediately resign from their posts. It is evident from the silence of Chief justice of Delhi High court and of CJI that they have no wisdom and courage to protect the lives and livelihoods of it's honest and innocent citizen and to uphold the constitution and rule of law. They are so fearful and terrified from the accused in this case or from the governments that they cannot take proper legal action and cannot pass an order against the voters and supports of BJP, still in public forums on camera Chief Justice of India says that there is no external/political pressure on the judiciary! If there is/was no external or internal pressure on him or on the Chief Justices of Delhi High court, then why they are not taking cognizance of serious offences mentioned in my complaints for last two years? Who is preventing them from taking legal action? I have lost my Delhi judicial services examination, 2022, all Books, All Relevant Law Bare Acts, three phone and other belongings only and only due to their Silence and conspiracy, where should I go to get justice? and why I should not make complaint against them? They are not the creators of my life, why I will allow them to destroy it like this? We don't know how many dreams are crushed in this manner by these corrupt people. They only wants to select their own near and dear by hook or crook in the judiciary, by throwing us out unlawfully. I'm not accepting this attitude of biasness of Delhi High court.

Their silence proves the fact that whatever harassment I had faced in Delhi is not a crime under the laws! and if I will also do the same thing with anyone, no court or government will take any action against me too? If bribery, extortion, economic exploitation, mental harassment, snatching of phones, law books, other belongings, breaking the locks of my rented rooms, preaching of privacy, abuse of powers is not crime, It means all the honest, poor, responsible and hardworking citizens are criminals and are not worthy of living their life freely, peacefully and fearlessly in this country and cannot become a judge or public servant without becoming a Corrupt, criminal, brutal and rich person first and without joining the BJP first. For me such state is called a Terrorist State And no one would like to live in such a Terrorist's State like a slave.

Even after getting the required eligibility, knowledge of laws and juristic skills and even after doing hard work, I was not allowed to enter the judiciary on merit. Delhi High Court and double engine governments have illegally snatched my post from me by committing conspiracy and by abusing their high handedness and powers. I have not seen this level of hate & corruption in any other country of the world. This is the extreme level of hate and mental illness of a person, governments or an institution like judiciary who are treating it's ordinary citizen like slaves and animals. CJI was also not taking cognizance on my written letter, then on 22 February, 2023, I had applied online to get instant legal aid lawyer (to file a formal writ petition before the supreme court) by filing an application to the Supreme Court Legal Services Committee through their National legal services authority's app, that Application was also suppressed and was not entertained by the legal aid committee, No reply was given to me and no inquiry will ever happen against such authority.

So, As a citizen of India, I was not given access to justice to protect my life, career, personal belongings and livelihood, legal and fundamental rights. They have treated me as a worthless citizen out of their jealousy, hate and ill will and in arrogance of their powers and positions. I was not given instant legal aid lawyer to get justice through due process of the laws neither by Delhi High Court legal services committee nor by the Supreme Court legal services committee on the undue interference of these corrupt-cum-rich accused, and their advocates and governments.

They had closed the door's of courts for me, so I had tried to tell the public about this by opening an account on X in 2022. I had written about it, within 2/3 days they had blocked that account too, so that public could not know about my case. All the accused in this case are getting protection from the Delhi High court, from it's legal services committee and from both centre and state Governments. All are treating me like I had committed a crime by coming in Delhi and by making complaints against my two landlords, against the corrupt practices of Mukherjee Nagar police station, and Delhi women commission for giving Zero grade services to the women in seeking emergency help and against Delhi High Court legal services committee for not providing instant legal aid lawyer to protect my life and legal rights as a tenant. Simultaneously, I had made some complaint against the arbitrary, unlawful and biased use of law and court processes by the local police, SDM court, Revenue court on the undue influence/interference of the then CM of HP Jai Ram Thakur. In both the states, Instead of protecting me and my family's life and legal & fundamental rights, they were hatching conspiracies against us and were training the accused how to harass her and her family unlawfully. I had not tolerated their such behaviour, and I was raising my voices in both the states, therefore, they all had consulted each other in February 2022, made a plan and decided to destroy my life for forever by abusing their powers of double engine govts and snatched my post of Delhi judicial officer through Delhi High Court at the time of preliminary examination. Both hired female bauncers of Pradeep Bajaj (i.e. Poonam and Babli) had threatened me many times during two months, "we will destroy your career", had issued threats of rape and murder if I will not vacate the room of Pradeep Bajaj and had attempted to kill two three times and had told me that, "everything is planned, you are not understanding anything, no legal action will ever happened against us whatever we will do with you because police and DWC is with us, that's why they are not taking any action against us despite your repeated complaint against us. Money is everything, we will give money to them and nothing will happened against us but we will destroy your Career, we will put you in jail by making false cases against you etc.etc. and Modi will not allow any media to cover your story."

Two years has gone, really neither the High court nor the CJI has the courage to take legal action against them despite my written complaints. On 6th and 9th February, 2022, Mukherjee Nagar Police Station had

also told me, you vacate the room of Pradeep Bajaj without any court's orders, there is no need of court orders to evict you and go back to your home, we will consult the local police of your area, because you are not vacating the room of Pradeep bajaj without any orders (Pangi police, against whom I and my family had already made several complaints for suppressing our complaints/statements about suppressing our legal rights of exclusive possession over our Ancestral property, for making false police reports and orders against us, for registering false cases and for unlawfully detaining my mother on 26-27 December, 2020 for 24 hours on the orders of CM Jai Ram Thakur U/1100 helpline number, for NOT accepting the arbitrary and biased Division of property by Three people called Tirth Raj, Jai Lal, Ashwani and who were the Voters of BJP, so that he could secure their votes and make his voters happy. Local police, SDM, revenue officers were acting like their agents from 2018 onwards and were not recording their complaints in police station and statements in court records regarding adverse possession and limitation period. There was no other reason to harass my mother and family.

Even after mentally harassing me and by failing me in DJS preliminary exam-2022, these corrupt people were not satisfied. They had fear that she is legally educated and she will either go to the supreme court against us or she may sit on strike outside the PM's Residence or on public road in Mukherjee nagar, after hearing her harassment story, public will come in her support and they will forced the governments and courts to take legal action against us. So, Mukherjee Nagar police station had unlawfully sent me at Nirmal Chhaya Complex, Jail road, Hari Nagar, Janakpuri, New Delhi-110064, in night hours of 20th september 2022 to detain there, without any orders of any court. No court had ordered that Ms. Pinki Devi should be sent to the Normal Chhaya. Then who was deciding this (indirectly) if not by the Governments or by the chief justice of Delhi High Court? Under the rules, women and girls are "admitted and discharge" from this Institution as per Court Orders only but I was unlawfully detained there for four days without following any rules. During my detention, even I was not aware where I was detained. It was looking like a jail-cum-mental asylum.

Later, I came to know that this was a Protective and Corrective Delhi Govt Institution created under Immoral traffic (Prevention) Act,1956. And I was shocked to know that Instead of protecting my life, they were tortureing me inside this Institution to break me mentally and physically. I was detained without informing me and my family so that no one could hear my voice. They could not kill me in Mukherjee nagar due to my public alarm so they may had planned to kill me inside this institute by starvation or by applying mental and physical torture. Therefore they had not given any information to me and my family about this place of detention. So that they can throw me anywhere after killing inside this institute. There, they were giving different treatment to me. In four days, I had taken only 1cup tea (that had also caused mouth infection) 1 cup milk, two biscuit of Rs. 5, and 50 grams of dried Channa, other than this I can't eat anything. Two days before detention too, I had not eat anything. My stomach was empty, my body was shivering due to weakness. I had lost my energy but they were not giving anything to eat. In my bags, all the material of a kitchen was available but I had to throw in dustbin because they were not allowing me to go outside to search a room for myself without the permission and presence of police. I had 1kg fruits in my bags, so on 2nd day, I had taken to room to eat so that I could get some energy, the welfare officer Pooja Sharma came to check the room and instructed one lady to take away her fruits and says, "We don't allow here to bring anything of yours." She snatched from me, were gone outside and distributed my fruits between the staff and finished my fruits. So called Welfare officer, Pooja Sharma was behaving like a Talibani commander to mentally and physically harass me on the instructions of Delhi police. She was openly instigating the staff to assault me and mentally harass me in every possible way. She had intentionally kept me with four mentally ill women, who were either laughing alone or crying or shouting anything, one woman Kiran and her minor daughter were so aggressive that they were ready to assault me without any reason on their instigation, two women were of such mental conditions that they were discharging urine and stool on the floor of bathroom and the staff was putting lock on the gate of the 2nd floor for 24 hours. I was forced to live with mentally ill women, in anger they could have killed me. They had put my life in grave danger. They had other vacant room too but they were not sending me there, for my safety. Welfare officer Pooja was keeping my phones, books, money, ATM card in her custody and my privacy was breached, they were checking everything in my 15 bags in my absence on the instructions of Delhi police, and then selected books, law bare acts and all other valuable things were taken from my bags. I was forced to live a life worst than a criminal.

Even criminals in jail are allowed to read or write something of their choice and are allowed to talk with their advocates and family members but I was not allowed to talk with anyone. In 4 days, she had given me my phone only for 5-6 minutes to talk with my brother, without completion of conversation, she had snatched my phone. I had seen such type of mental harassment in pictures only.

They were behaving like I had committed some serious offence like sedition. Even Kasab may not have received such treatment in jail. I was forced to live like a criminal inside this jail without having committed any offence. I had requested them to let me go from here. And had told them, I don't want to stay here, police had told me we are giving security for one night only and you cannot keep me here against my will but they were saying we have not called you here, police has submitted you here and they have not told us to release you. On raising objections to such behaviour, One lady staff Bhavna was threatening to put me in Tihar Jail. They were hating me because of misinformation of Delhi Police, about me, so the staff was ready to kill me on Delhi police's instigations. I had to save myself from dying in their hands.

So, I had only one option, escape from this torture house. When I had tried to escape from there in night hours by jumping from a tree (I could have died there even in escape attempts) then they thought that she has informed her family members, and they may register Complaints against us, if anything happens to her here, and they may lose their jobs. Then, they decided to release me alive but again selectively snatched my dearest Delhi & Higher Judiciary's all practice books, UPSC's Preliminary exam practice books, atleast 35 relevant Law Bare Acts (In 35 Bare Acts, three or four Bare Acts were of HP local laws, those Bare Acts were useless in Delhi, but still were taken away from my bags of books (I believe) on the instructions of HP police or CM-Jai Ram Thakur because I had used some provisions from these Bare Acts to protect my family's legal rights before the Revenue Courts-Pangi in 2019, to senior civil court Chamba in 2021, and 2/3 kits full of pens, and other valuable things, watches, bags, lock, clothes, footwear, two pillows, two blankets etc, (all basic needs things to cause financial loss so that I could be forced to Leave Delhi) My health was so weak that I was not able to walk and had to go DDU hospital, and was staying in a rented Room of Kamal Sharma RZD2/208 jeevan park by paying Rs.4500 per month. I had to keep silence because I had to save my life from this terrorist organisation called Delhi police. After recovering my health, when I wrote to the Chief Justice of India on 27th Dec. and to Supreme Court legal services committee on 22 Feb. 2023 to get an legal aid advocate (my address was mentioned in both) and Delhi police got information where I was staying and again started mentally harass me to force me to leave this room too through this house's owner. After three months, suddenly Kamal Sharma's behaviour was changed, It was looking like Delhi police was giving him free of cost alcohol to consume or money to harass me and my mother, he was coming to the door at 3rd floor to threaten to leave the room without any reason, and was forcibly sending 3-5 unknown Gunda type males daily inside our room to see it to give on rent or to sell the house to them (they may be of BJP's workers) despite my repeated objections for our safety. In the same house, their 1st and 2nd floors were vacant, he was not sending them there to see those rooms and was also not sending to 4th floor, where a male was staying on rent. Then one day he had cut the electricity wires of my floor to force us to leave the room despite getting full advance rent. It was looking like police was instigating or forcing him to do so. We again became fearful of our lives and decided to leave that room after 4 months, to save our lives. The purpose of the police was to keep mentally harassing me for staying in Delhi, so that I could not go to courts and public against their harassment, illegal detention and for misappropriation of my DJS's books, law bare acts and other belongings. The irresponsible CJI and supreme court legal services committee, couldn't do anything against the accused named on my complaints/application but again gave my address to the Delhi police to cause further harassment and allowed extortion through house owner. Police was already behaving like a terrorist organisation to harass me because I had made written complaints against them to DWG for taking money from my landlord to suppress my complaints.

This level of mental Torture could not be given to anyone, without the involvement and support of governments and courts. If staying in rented accommodation in Delhi and making complaints against house owner, (who are forcibly taking rent in cash for months, not giving any rent receipts to the tenants, and are forcibly and illegally charging 300 to 500 as water and electricity charges without showing any copy of bills, knowingly will not make rent agreement then after one or two years starts mentally harassing, insulting and defaming the tenant by spreading misinformation that, "you have not paid us any rent, as you have no proof to show and now you have to vacate the room") and if, making complaints

against any such Corrupt public officer, paying rent in cash is a crime, than make it a crime first in the statute books, and declare it publicly that making complaints against the rented house owners in Delhi, against BJP voters, against BJP-CM, against corrupt police, SDMs, Revenue officers or Court Staff, legal services authority is a Serious offences under the law. Then, We will behave in another way or we will not go to the police or Courts to report the crimes but atleast we can snatch the same thing from them by applying the same mode on them on our own strength. They have unlawfully santched my dream, dearest books, phones with simcard multiple times, even comb, clothes footwear so that I could not go to courts or any public/ authority instantly, cause irreplaceable loss, disturb my life, mental peace in Delhi and my family's in HP, by hatching conspiracies and acting like a terrorist organisation, now they cannot expect from us, "we will not claim damages and compensation from them under the law." I had gave two years to the constitutional courts of India to repair the damage caused by the state agencies in Delhi but they are failed in giving justice to me. Still I am giving 15 days more to act to both the governments and Supreme Court to correct their mistake and REPAIR the damage they've caused to me and my family by keeping silence and give immediate Justice by giving appointment as a judge at the Apex court and by paying compensation of Rs.15 crores claimed in my letter to CJI otherwise I will recover my losses on my own by conducting a National Open And Live Trial, and Delhi High court and supreme court and both the governments will have to keep the same silence on my trial to Recover my loss as they had kept their eyes closed during and after my harassments in Delhi. I have acquired sufficient professional qualifications, knowledge and skills to do the job and I will do it openly and proudly without taking permission from anyone.

And I will snatch everything from them in the same manner they have snatched unlawfully my dream job and valuable things from me. I will sell their houses and properties in public auction and after recovering my damages from their movable and immovable properties, rest of the amount or properties will be distributed to the poorest people (free of cost) to raise their standards of life. I will take Mukherjee Nagar Police Station Delhi, Office of Delhi Women Commission, and Nirmal Chhaya Complex, Hari Nagar, Delhi in my possession and will use for either to give free legal aid services to the poor or will allot to the poor girls or boys of different states to stay there (free of cost) for their preparation of judiciary or Civil services examinations. I have objectively and carefully studied their work for last 8 years, they are completely working against the legal, human and fundamental rights of the POOR students/citizens/victims and disturbing the public peace.

80-90% crimes in Delhi are happening due to the corruption and incompetency of half educated and unprofessional policemen, Delhi women commission and by the silence and non-action of judiciary. They all are doing business over our legal and human rights to get bribe money to fill the stomach of their families at the cost of our career and lives and getting favour from corrupt-cum-rich or influential people, thereby disturbing public peace and harmony, preventing sustainable development of poor citizens, disturbing economic balance of society and creating more brutal and habitual offenders by training them in harassments of economically and socially weaker people or students and instigating the offenders to commit more serious crimes against the victims/complainants like they had done in my case. And I will punish all of them who are involved, as per the law and will put them in the same tourture house at Nirmal Chhaya Complex, Hari Nagar, for rest of their lives, only than they will come to know the value of other's life, time and money. They don't deserve to live in society because they are parasites and wants to live like king at the cost and hardwork of others by snatching everything from them thereby disturbing the social balance, peace and growth of a civilized society. And to bring the truth out, I will conduct open and live forcible Lie Detector tests and Narco tests on each and every one who was involved in my harassment and in destroying my career in judiciary.

Above mentioned incident has not only resulted in significant financial loss and hardships but has also left my family and me deeply traumatized and concerned about our safety and security throughout our lives (Now, anything happens to me and my family, Prime Minister, Home Minister, Women affairs Minister, social justice minister, Ex-CM of HP, Jai Ram Thakur, chief justices of three High courts and CJI shall be personally responsible for that alongwith the accused persons mentioned in my complaints. I firmly believe that Without their support, instigations and involvement, I and my family cannot get such extreme level of tourture. The entire State system's behaviour is not less than that of a Talibani people. It is shocking that governments and Judiciary was feeling insecurity and jealousy from a girl who was judiciary's aspirant and all had decided to destroy her career in judiciary at the threshold. They have

tortured me for doing hard work to get selected in DJS on my own merit and for becoming a legally educated, honest, responsible, hardworking and for becoming a law abiding citizen of India. They all have put our life on vegetative state for last 6-7 years to stop me from raising my voices against their illegal, arbitrary and unlawful activities in three states of India. As an honest citizen/student or as an advocate we don't deserve such treatment from the governments and judiciary. It was my moral and professional duty to raise my voice against corruption and I had done that in three states. If that's a crime then stop all the advocates from registering or defending cases in courts and closed all the Law school, Universities, courts and burn all the law books and constitution and Stop taking judicial services examinations.

HPCM-Jai Ram Thakur was unnecessarily (in arrogance of his political powers) using entire State System for five years to harass my family on the instructions of his BJP supporters against whom I had made genuine complaints. He had made my family's life like hell through Ashwani, police, SDMs, Tehsildars, naib Tehsildar and civil court Chamba and thru CM Seva Sankalp helpline number 1100 without hearing us. He was behaving like he is a God and he can do anything to us without following any law or legal process, and can distribute our ancestral property in arrogance of his powers as Chief minister and we have no right to go to the courts against his illegal and arbitrary actions. He had created such an insecure and terrified environment for my family that we are not feeling safe inside our house too.

There is complete lawlessness situation in society for the people like us. It appears that we are living in a Terrorist's State. Police with BJP supporters are forcibly coming, threatening and taking everything from us. Even if our life is in extreme danger, no one is there to take legal action against rich, influential or against BJP's supporters, habitual offenders or against terrorist like public officers. Corrupt Police has created such an unsafe environment for complaints/victims, as they have no right to live peacefully in this country. I came to Delhi to join the judiciary and I was not begging or taking anything from anyone. I had worked hard for years to get required qualifications to join the judiciary. I was determined to become a judge and CJI at the Apex Court through my hardwork and dedication on merit, But Delhi High court has failed me in DJS exam-2022 by hatching conspiracies after knowing about my dream of becoming CJI by breaking the lock of my room at N-2 first floor at Mukherjee nagar, delhi and have killed my dream of becoming a judge, they were aware due to age bar she cannot give this exam again. I couldn't qualify my Delhi Judicial Services examinations of the year 2017, 2018, 2019 only and only due to the extreme harassments of Pradeep Bajaj, his family & his PG's Girls still I was keeping courage and was maintaining peace and patience. Police and Delhi women commission were saving them from legal actions every time on my complaints of harassment. I was not even gone to my home for two years to qualify it in 2022. I had lost my eye vision and health in preparations for judiciary but they have forced me to leave your dream. After notification, I was counting my days to join the Delhi judiciary but I was not aware that crooked, Corrupt and Talibani terrorist like commander will come again at my door, will forcibly break the lock of my door, will break my room's light wires and switches, wall and will snatch my phones multiple times and will destroy my sim cards, will snatch my all basic needs things and books, will prevent my legal aid Application and will snatch my Delhi judicial officer's post from me by abusing their powers and posts by hatching conspiracy.

Now, how I will reach at the supreme court to become a judge on merit, if not given an appointment via article 124(3)(c)?

My educational qualifications, knowledge of law, honesty, integrity, commitments towards my profession, legal and juristic skills are not inferior than that of any other judge of the high court or of the supreme court of India, so why should I keep silence? So, if I will not get appointment via 124(3)(c) within 15 days, I would have no other option but to snatch my constitutional right to become a judge at the Apex Court on my own (Delhi police, DWC, Delhi High court & it's legal aid office was working at nights too in hatching conspiracies against me to destroy my life and career in judiciary in 2022. Now, both the Governments and Supreme Court must work at day and nights to give Justice to me within 15 days). Delhi High court, by suppressing my written complaint, by unlawfully denying legal aid lawyer to me and by failing me in my Delhi Judicial Services examinations-2022, and by illegally detaining me, by snatching my Law books, Bare Acts, phones, simcards and other belongings. And by dismissing my mother's 2nd appeal without merits by Jammu and Kashmir High court and by harassing and denying justice to my family in HP for last 7 years, Governments and courts has created a volcano for themselves. Now, if this volcano erupts at any time and burns their hands and houses, I shall not be responsible. As an advocate, I had taken an oath

that I shall protect the constitution and its values and I will protect the human, legal and fundamental rights of any citizen including my family and I would do that at any cost.

Constitution had promised us, and had ensure that judiciary will function freely, objectively, and with utmost integrity and independence But I found in last 10 years that judiciary (from top to bottom) has become so fearful and bias that they are not applying the basic law in cases where one party is supporter of BJP or pays them money to get a order/police report etc. in their favour, which is very very dangerous and can't issue a show cause notice to its corrupt officials and can't issue a protection order to save a woman's life from being raped and killed brutally. And can't allow an advocate to a woman like me in Delhi to protect my life, career, belongings and legal rights and my mother in JKL and HP to protect her human, legal rights over ancestral property on merits of the cases. They are treating us as we don't deserve to live our natural life freely and peacefully and playing game with the life of poor citizens for years and destroying our lives and passing direct or indirect orders on the instructions of influential, rich, political people as they are the rule of law. I have found that no one in the judiciary have nothing to do with the rule of law or any other principles of natural Justice.

How they can expect from the citizens to follow the rule of law? Judicial officers are taking lacs of rupees as salary committing conspiracies with habitual offenders who gives them money and sending them to harass the honest people. I have seen this in three states that their police stations, their free legal aid committee's office, and courts and Delhi women commission are working as safe house for the rich, influential, habitual offenders and working as torture/harassment house for the complainants/victims. No victims like me and my family would ever go to these Torture houses again to report a crime, or to get legal aid then where should we go as a citizen, when all the courts and public institutions or authority denies to give justice after getting bribe money and keeps silence at the needy hours?! There's no "Private" emergency helpline number or Private courts/Institutions or private Protection officer in the country of 140 crores people who could atleast save our precious life, property, livelihood and career 'in emergency conditions' by passing an instant order under the law against these brutal habitual offenders or corrupt police officers, legal aid officers or SHO who either sleeps with accused or takes money from them to suppress the genuine complaint and will not take legal action. If private court or justice institutions would have in existence, I could have saved my dream, belongings and legal rights over property by paying atleast minimum fee, like Private Doctors do.

By looking at the pathetic condition and zero grade services of present police , legal aid offices and judiciary, tears comes from my eyes. Poor people are completely helpless, neglected by the police, governments and judiciary. Accused persons are living like king by committing brutal crimes against the girls of country, mentally harassing them for years, killing their dreams, snatching jobs illegally, giving torture or getting harassment to disturb study, destroying exams, extorting money against rules, still enjoying the life of a class 1 citizen. Raping, molesting killing women cutting in peaces and throwing in forests, in rivers or boiling them to throw out, forcing them to walk naked on roads by taking undue advantage of aloneness or by taking advantage of their mental or physical weaknesses or financial hardships, And police officer, court's officer takes money burn them in night hours or sleeps with accused to save them, matters over!

Pashmeen Kaur, Puli@Poonam Saroha and Babli@Bhagwanti alongwith their family, friends and relatives could have done the same thing with me in Delhi on the nights of 19th and 20th september, 2022, if some brave girls of nearby PG houses had not saved me by standing with me throughout that night. Their entire gang was ready to kill me by taking me and my belongings forcibly in a private vehicle to an unknown place in night hours in front of 200-300 nearby people no one was stopping them and police was indirectly supporting them to do anything with my life and belongings. I was alone running here and there on the road at night to ask for help to save my life but no one was helping due to the fear and terror of this terrorist organisation called Delhi police. Currently my three cellphone handsets (with all relevant evidences against them) with three simcards are in the hands of Delhi police and Pradeep Bajaj and his two hired lady bauncers. Out of my three numbers two numbers i.e. 9319327582 from 8th July 2024 and 9310228486 from April/May-2024 are in operation on WhatsApp. I have doubts that they are using my numbers in their illegal drug businesses. I had informed the IO of Mukherjee nagar police station about their involvement in illegal drugs trade but he didn't take any action. Where the person would go to protect herself or himself, in such a dangerous situation? This gang had snatched my phone from my hands but the shameless, parasite, untrained and corrupt officers of Mukherjee Nagar police station were spreading



misinformation to the public, "She is mad, don't give your phone to her, don't talk with her, don't stand with her to help her, Don't bring complaints to us on behalf of her, because you don't know her. If you have sympathy with her then take her in your room and keep with yourself". I was declared mad, worthless in the eyes of general public. I was made completely helpless, insecure, terrified and mentally disturbed by the corrupt officers of Delhi police, so that they could save their kingdom of corruption in Delhi. My phone was snatched and sim cards were scratched by this gang of Poonam, Babli and Pashmeen Kaur on the instructions of Delhi police, so that I could not call anyone. Pashmeen Kaur was forcibly sending her own private electrician in every room to charge Rs.500 every month as electricity charges without making any bill.

If, there would have a private professional Institution/Court in operation to get instant access to justice at 24x7, I could have immediately approached them by paying their minimum fee to take immediate legal action against these people and against this terrorist group called Delhi police to protect my life, belongings and livelihood on merits of the case. Despite knowing the facts and circumstances of my case in detail, Delhi High Court and its Legal Aid committee was behaving like a DEAD institution for me and remained silent in needy hours. They may had clapped in the background on creating terror, insecurity in my mind and for detaining me at Nirmal Chhaya complex and they may had allowed the police to snatch my books, bare Acts and and other valuable thing by isolating me from the Mukherjee nagar and by detaining me at Nirmal Chhaya complex. They had no intentions to give me Justice on the pressure of this terrorist group because I was an outsider to them. I have seen, Police, Judicial officers, legal aid staff only wants you to go away from there, so that they can sit comfortably from morning to evening and could talk over unnecessary and useless things of their own and get salary every month from the taxes of public. In essence they are getting legally paid from our taxes to destroy our lives illegally and getting promotions to snatch the hardwork of our life, how a wise man/women can accept this gross injustice! If someone is making complaints of it, the entire system is standing with them and not allowing any actions. As a citizen this has hampered our sustainable development for years. Police, DWC and Legal aid committees are working like a Terrorist group co-ordinating each other to get extra money from the litigants and working against the legal, human and fundamental rights of citizens and this will destroy the country and humanity. And this is the reason India is still called 3rd World country. They will never allow this country to grow and to become a developed country. They all have destroyed and crushed many dreams and lives of brave, honest, responsible and hardworking citizen for years who were/are capable to make India a developed country and have also destroyed my dream of becoming a judge at the Apex court and CJI, in arrogance of their powers only because they had upper hands in the system and treating us a 3rd class citizen.

All the crooked and Corrupt people who are involved in destroying my career in judiciary, has 0% contribution in my upbringing, in my personal growth and in my education, in creation of my life, in my learning of my legal and juristic excellence, so I would not allow them to destroy my hard work of life in this manner. They all are not even capable of producing a single human cell or organ to assist my life on their own capacity and are not even capable of giving or maintaining a peaceful, safe and secure environment to its judiciary or civil services aspirants and women players but they are destroying our lives as they have created it and given to us as a gift! They thinks that they are Gods and have got absolute power and legal right to destroy the precious lives of citizens and my career in judiciary. This is not the rule of law in any sense and I will not allow this terrorism anymore. They are forcibly ruling us like a terrorist organisation, why would we accept this Terrorist's rule? I would not pass this corrupt justice system to my next generation and will fix it within six months. I had worked hard to make myself eligible to become a Judge. The only mistake I had committed that I was staying in a rented Room of Talibani like man called Pradeep Bajaj, who was not following any law, was not controlling his tenants who were disturbing me every day and night, was financially exploiting the girls for last 20-25 years and then was humiliating and insulting by spreading wrong information, was forcing us to pay the full monthly salary of his house help without working for us, was taking rent in cash and then was giving wrong information to his PG's other girls that she is not giving us rent and then they coming at my door to demand rent on his behalf. (From where I pay him double rent every month) when I denied to pay then they were assaulting me and were not losing any opportunity to do mentally disturb. He had made it a profession and had thought no one would make a complaint against me. He had accumulated crores of money in cash from

the girls of country for last 15-20 years, so that he can buy police IOs, SHOs, courts, authority or any other individuals at any time to save his kingdom of looting the girls of different states. During my stay in their house, 2016-2020 every month three people were coming to demand rent in cash and were shouting, fighting and were harassing all the girls for even Rs.25/50. Always says, "we have took loan from the bank, so we have to return. In 2022, (after two years of lockdown) suddenly without working anywhere, their family was became so rich that instead of going to the courts to vacate the room from me through court processes, they were able to hired two female lady bouncers and three-four male bouncers by paying one lac in cash and may be one lac in kind to vacate a (perhaps 5x8 feet kitchen type) Room from me, and gave my Six months advance rent in cash to Pashmeen Kaur, and was giving money to the Corrupt officers of Mukherjee Nagar police station to not register FIR against him on my complaints, was giving money to Delhi women commission to keep silence on my complaint, was giving money to the staff and secretary of Delhi High Court legal services committee, for not allowing me an instant advocate and may had given money to the Chief Justice of Delhi High Court and CJI for keeping Silence over my Written complaints of July, 2022 and December, 2022 And still they were ready to spend more amount to illegally vacate another room in the same floor from another girl called Alok Prakash from UP in the same manner, without following any legal process. This family was distributing cash like they had a printing machine of their own. Instead of giving me protection from his torture, police, Delhi women commission, DHLSC, High Court & supreme court have saved the kingdom of Corruption and allowed my harassment, as I had committed a serious offence by becoming his tenant for five years and by making complaints against them.

As a legal Scholar, I want to acknowledge the immense importance the judiciary holds in our democracy, serving as the ultimate guarantor of Justice, equality and rule of law. But as a citizen I have not seen them working in that spirit in my case and in thousands of other cases, which is disturbing and very painful. I hurts my soul every time. People are committing suicide by coming at the Apex Court, due to the judicial Dictatorship and due to the terrorism of police and courts still they have no shame and behaving like a blind person or institutions. If it is not saved immediately, 50-60% population will not be able to survive after 5-10 years. Rich, influential, habitual offenders and BJP's workers will snatch every from them in the same manner they have snatched from me and my family in Delhi, HP and JKL and may kill them or they will die due to the exploitation, starvation, extortion, snatching of essential things and harassment by these habitual offenders. As a responsible citizen of India, I firmly believe that a fair and impartial judiciary is the backbone of a just society. However, my personal research and experiences in three states, recent reports and rumors circulating among the general public about the presence of uncontrolled corruption, exploitation and lawlessness in the country is showing the real and opposite pictures of the Indian judiciary and Governments, have raised my concern and disturbing my mind. If we have to survive in present conditions as a citizen we need at least 1-5 lakh money every year to give bribe to get public or private services, from where we will satisfy the greed of corrupt public institutions or authority?! . As a citizen we have to pay full taxes to the governments then we have to pay 2nd type of taxes i.e. tax of their choice to rented house owners, to police, to SDMs, to revenue officers, to court officers, to legal aid officers. I have seen many honest advocates crying who were forced to give bribe money to get certified copies of orders or judgements on time. If they will not give extra money they will not get the required documents on time. People operating cyber cafe are demanding 500 to add address in the aadhaar card and to register a FIR 150-200 if police refused to register. In JK we were forced to give Rs.5000 only to get certified copies to file a 2nd appeal, otherwise they were making excuses of having no records. After watching all this I'm not able to sleep at nights but people sitting on the constitutional positions are sleeping in the day too and are not doing anything to save the legal, human and fundamental rights of poor people of India. They talks high in front of camera and acts at the lowest level offside the camera. It can be controlled and improved within one month but I have not seen that intentions in anyone sitting on the responsible positions. They have made no serious efforts to save precious human lives from unnecessary harassments, financial exploitation and hardships, and acting as they have not seen anything wrong, thereby allowing and supporting the Corruption, crimes, harassment, extortion, kidnapping, and snatching and are hatching conspiracies to destroy the lives of people like me who are making their complaints after getting legal education. If me and my family could not get justice in 18 years in UT-JKL, in Seven years in HP, and in 6-7 years in Delhi, (which would have been given within one week in Medical profession) no one is getting Justice from the corrupt courts except the rich and

influential and supporters of BJP. Corrupt Police and Judiciary has created a war like situation for the poor people to get access to justice. I want to save every precious human life from this brutal harassment of police, judiciary, legal aid offices and will do it as present Judiciary and Governments are only serving 30-40% of rich, influential & habitual offenders of their choice instantly. All other citizens are either waiting for 30-50 years or dying without getting justice. They have completely ignored and neglected the human, legal and fundamental rights of poor citizens for years and have closed their doors for the POOR, HONEST and Illiterate people and they are doing this intentionally so that no one can rise above them and they cannot face tough competition. As a responsible citizen, it is my constitutional duty to protect and improve the natural environment required for human existence, and I will protect that whatever it takes from me. If I will not get the appointment through article 124(3)(c) too then I am taking responsibility on my shoulders and will not allow these terrorists to destroy or snatch any other life, house, land and dreams of poor people. I will give instant access to justice to the poor, honest and illiterate people of India, free of cost for 24x7 hours as a Private Judge of a private institution/court by establishing it. And Whoever, will prevent me from doing my service, I will take them to the UNO or International court of justice to declare them a Terrorist individual/State/institution/organisation, to save the humanity from their torture. If I will not get immediate appointment at the Apex court, I have no other option but to choose above mentioned way to serve the crores of poor people of my country.

Therefore, it is my humble request that you exercise your Constitutional responsibility and ensure my appointment peacefully and With Dignity as distinguished jurist to the highest Judicial Institution of the country and ensure urgent arrangements or make new norms to give instant 24x7 access to justice to the poor people of India.

We were taught in law classes that Supreme Court plays a pivotal role in safeguarding the principles of Justice, equality, and liberty thereby ensuring the rule of law prevails in our nation but in reality it has no courage to take action against any rich or influential people and against corrupt public officers. Infact they are the real saviour of the kingdom of looters, criminals and habitual offenders for years and cheating the poor citizen by showing them the dead words of rule of law. This Corruption has taken everything from me and my family in last Six to Seven years, But now I will Destroy the kingdom of corruption and I have taken this oath that I will not die before killing this Monster called Corruption.

Article 124(3)(c) of the Indian constitution empowers the President to appoint judges to the supreme Court. However, it is a matter of concern that the appointment of a distinguished jurist under this provision has been long over due. It is imperative to bridge this gap and ensure that supreme court has the benefit of the insights and experience of a jurist of exceptional eminence like me. The appointment of such a Distinguished Jurist would elevate the Quality of Judicial Decisions, strengthen the Credibility of the Institution, and enhance public confidence in judiciary.

I Urge you, Your Excellency, to prioritise and fill the current vacancy created by justice Hima Kohli or vacate the seat of justice Satish Chandra Sharma as he is elevated to the Apex court for keeping silence on my written complaint. For me, if he and CJI has no courage to take legal action on my genuine complaint and can't give justice to me, they cannot give justice to anyone then on what grounds they are elevated to the Apex court? By giving an immediate appointment to me at the Apex court consider that it is the integral to the smooth functioning and preservation of constitutional values that we hold dear. The object of Article 124(3)(c) was to open a wider field of choice for the President in the matter of appointment, it is high time to use it to save the Career and Dream of a brave tribal girl who had aspired for representing her community at Supreme Court in due course of time and was working hard for years to achieve that on her own merits. I believe that a distinguished jurist like me, would bring invaluable expertise, perspectives, and impartiality to the Supreme Court bench, enriching the judicial discourse and ensuring a fair and just legal system and it would impact diversity at the supreme Court. ST representation in judiciary is only at roughly 1.54%. Infact, no judge from Scheduled Tribes has been appointed to the Supreme Court since its establishment.

Given the significance of this matter, I kindly request you to expedite the process of my appointment and my commitments to the profession will provide sufficient evidence of juristic eminence and the highest ethical standards and unwavering commitment to upholding the constitution of India.

It is crucial to ensure that the individual appointed possesses the requisite knowledge, experience, and integrity necessary to fulfill the responsibilities vested in a supreme court judge, I have acquired all that in last 14 years of my training of my mind.

Your Excellency, I have utmost faith in your judicious decision-making and your commitment to upholding constitutional values. I trust that you will take immediate action in this matter and will make appointment of me [i.e. Ms. Pinki Devi](#) as distinguished jurist within 15 days of receiving this email to the Supreme Court bench, thereby fortify the judiciary, to give due representation to Schedule Tribe Community at Supreme Court and Reaffirm the faith of poor people of India in justice system. I am committed to build a corruption, harassment, extortion, exploitation free society by giving 24x7 hours services to the poor and illiterate people that future generations will be proud of and I am available to contribute and support any initiatives that aim to eradicate corruption, exploitation, extortion, harassment and other crimes from the Indian society.

India has the second-largest tribal population in the world, 75 years of independence has gone but not a single person of schedule tribe community was elevated to the Supreme Court, which is disgraceful for the country. The mount Everest was scaled in year, 1953. But in 73 years, no ST Judge could reach at the Apex court due to the discrimination and domination of few families and due to preferential treatment of other categories by the Indian Judiciary. Schedule tribe club is completely deprived of the opportunity to use their knowledge and skills in supreme court for long periods, their skills, knowledge and juristic excellence were never noticed by the judiciary. So, no candidate of ST Community or jurist has so far found a berth there, but this time a competent and courageous daughter is knocking the door of Rashtrapati Bhavan to offer her services and to use her legal and juristic skills in the service of poor people, and I am saying this with utmost responsibility that if I don't deserve to be a Judge at the Apex Court, no one deserves to be there. I am only asking my rightful place in judiciary. I could have achieved it on my own efforts but now I cannot do that because they didn't allow me to enter into the judiciary. I'm ready to prove it today itself before the supreme court or in the parliament. Higher Judiciary is not a private property of few people, so I am demanding my fundamental rights under article 19(1)(g), 14, 16, 21 of the constitution of India on merit. There is a lack of representation of women of marginalized communities, so it is high time to give representation to the ST Community through me.

As a student of Law, I have seen law in academia and have not seen the law in action or in courts. Seven years of my life was gone to fight with these Talibani like people to fight who were not allowing me to focus on my study and then in 2022 they have destroy my hard work of life by tampering my OMR answer sheet. Simultaneously

My family had made complaints in HP to protect their human, legal, fundamental right, Six precious years of their life has gone, no legal action was ever taken by the police, SDMs Tehsildars, civil court on merit, all are taking one sided action and passing biased orders against us and even High court have no courage to pass a single order on merits of the case because the offenders are the voters of BJP. They have hijacked the state judiciary.

My mother had registered a civil case in 2006 in Jammu and Kashmir to protect her ancestral property, from an stranger of her village who had registered a fraud Will by becoming a fake nephew in the courts, by kidnapping and unlawfully detaining the testator and by paying 90,000 bribe money to the revenue officers. Police complaint was made no action was taken. Civil case was before the three district courts and High court, all had decided to not give Justice to my mother, only because they were not getting bribe money from her. No legal action was taken against the offenders. So Three States have unlawfully snatched everything from us, whatever we had acquired by our own hard work and honesty in last 30-40 years. We had gave sufficient time to the High Courts of these states but they have denied to give Justice on merit. And we have 0% expectations from the supreme court too because they are sitting there for rich or influential advocates and people only. They have no time to hear the cases of poor people, they only sits over the files for years. We cannot wait for getting justice in next life. Therefore, I have no other option but to decide these three cases on my own by conducting an open and live hearings. My judgments/opinions in these three cases will prove my legal and juristic learning and excellence to impart Justice to the needy. I am already enveloped in the study of law for past 14 years and have trained myself to do the job efficiently. I can use my skills to give 24x7 access to justice to the poor people of India either through the supreme court judge or as a private court Judge. As a legal Scholar I cannot keep my eyes

closed when someone is dying due to the injustice of constitutional courts. So I will take the responsibility of providing 24x7 access to justice to the poor, illiterate and needy people.

Although it is imperative duty of the State to ensure that every citizen has easy and affordable Access to justice. But my family in HP and JKL and me in Delhi, couldn't get that in needy hours. They had made it a war like situation for us. As a citizen of democratic country, rule of law forms the bedrock of society, but we could not see that rule of law in practice in these three states. There is only one rule in practice i.e. rule of money and rule of politics. The law says, "Every individual is subject to the law, irrespective of their position, influence, or economic status" but this rule is not applicable on rich cum politically connected people, no action was ever taken on my genuine complaints in Delhi, HP and in JKL. Judiciary must ensure fairness, Justice, and equality, fostering an environment conducive to our nation's growth and well being of the people, but instead of helping us in our growth, they are hatching conspiracies to destroy our lives, career and dreams and they all are collectively preventing our sustainable development. They were behaving like I have committed a crime by becoming a tenant in Delhi and by aspiring for joining the Delhi judiciary. And my mother and brothers had committed a crime by taking care of our maternal and paternal ancestral properties in two states and by making and claiming lawful possession of the same in two different states of India.

Despite comprehensive Anti corruption laws that effectively deter Corruption and hold violators accountable, no one including the judiciary is following these laws. Laws are there merely as dead letters, which is disturbing the balance of society, mental peace of citizens, hampering our progress as a civilized nation and hindering the well-being of our honest, poor and illiterate citizens for years. It is undermining our democratic values, eroding public trust in judiciary and Govt. Institutions, and hindering equitable and sustainable development of crores of poor and legally illiterate people of India, atleast I am not ready to take this corrupt justice system forward.

Therefore, if the judiciary and governments will not open their eyes to fix the problem immediately, I will have no other option but to create a robust parallel private legal aid system, private courts and private police stations to give equitable 24x7 access to justice. Which is essential need to uphold and reinforce the rule of law in India. Medical sciences are going high and doing all efforts/researches and giving their services for 18-20 hours to save human and humanity from different diseases but judiciary and uneducated political leaders are going low and committing conspiracies and destroying human life by creating hardships for honest people by abusing their powers and posts to get votes or to get extra money or promotion and allowing harassment, extortion, exploitation of poor and legally illiterate people and making their life like hell. Corrupt people will not die if they will not take bribe but poor people will definitely die if no one will protect them from physical and financial exploitation of the rich, parasite or influential people. It is high time to take a stand otherwise poor will die due to starvation or due to injustice and I would not allow dehumanise the human.

Both medicine and law are professional courses and requires to have practical exposure in order to be able to impart quality justice. Medical professionals are allowed to private practice but law professionals are not allowed to private practice to impart justice on payment of prescribed fee. Poor citizen are losing their lives, houses, land, physical, mental and financial health due to the injustice getting from the present corrupt justice system which is completely hijacked by the political monsters, by rich/influential advocates and by the brutal criminals. Poor people have no other option but to die without getting justice.


In US, it has been a practice to appoint eminent jurists to the Supreme Court. In India too it is desirable to have women/men with outstanding legal and juristic learning be appointed to give quality justice to its citizens at the earliest possible time like medical services. The professors/doctors Who teach, are not barred from treating the patients and the same law cannot bar me or any other Law professional/Scholar to give Justice to the complainants/victims on merit of a case by following due process of law. Since appointment of SC judges via Article 124(3)(c) of Indian constitution has been silenced. The continuing ignorance of this mandate under the constitution reflects an innate constitutional trauma for legal Scholars and practitioners. I have invested my life on myself to become a good, honest and responsible citizen and judge to serve my country. I have already suffered a lot due to the harassment of all these corrupt people and now I will not take any appointment lesser than a judge at the supreme court of India. I deserve it because I had already prepared myself to achieve that on merit. If, I will not be given appointment via Article-124(3)(c) within 15 days, then, I would exercise my fundamental rights under

articles-19(1)(g) & 14 to Start Private Practice as a Judge by practicing the profession of my own choice. Studying law and becoming a good judge was/is my passion, I will not leave that for any reason. I have made myself of the Billion Dollar Girl to serve my country and I will take what I deserve.
